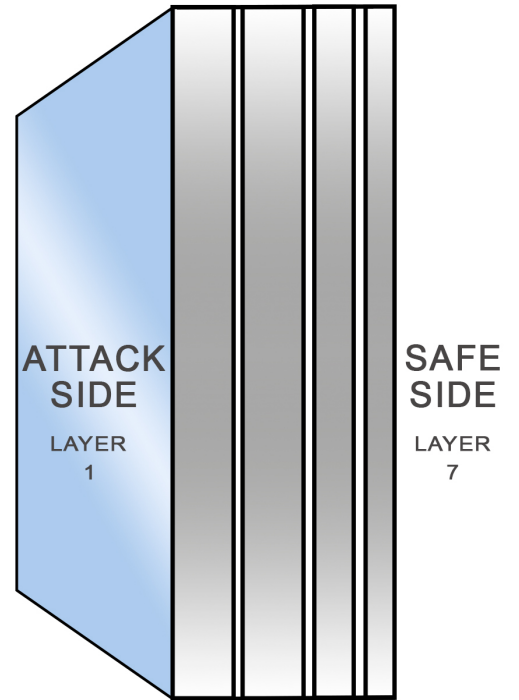

CARING FOR EXPOSED GLASS SURFACES

It is imperative to clean the glazing unit during and after the construction period to maintain optimum performance and aesthetic properties. To clean, use a soft, clean cloth and a mild soap, detergent, or slightly acidic cleaning solution (such as vinegar). Avoid using razor blades which can scratch the glass and exposed polycarbonate layer (no spall makeups). Wipe with a clean, lint-free cloth.

STORAGE

Prior to installation:

Store glass in a cool, dry place away from direct sun exposure. If possible, keep the panels in the original shipping crate to limit exposure to dust, dirt, chemicals, and to avoid accidental impact damage.
