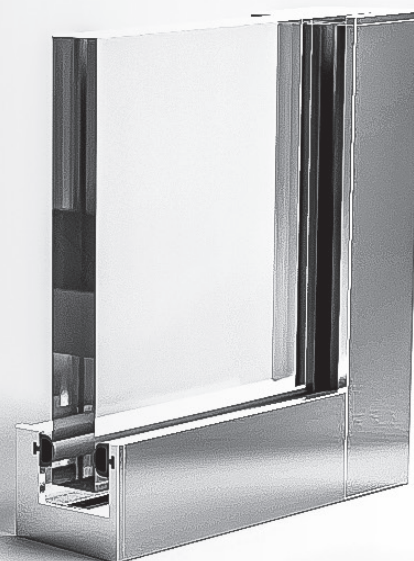

PRODUCT DESCRIPTION

The UFS-DC-BR-1 Door Conversion system by Riot Glass® is designed to replace the standard glazing in most aluminum-framed entrance doors used in storefront applications.

Our ballistic DC framing closes the gap of vulnerability by adding edge-to-edge ballistic protection to our ballistic-rated clear security panels.

Together, the UFS Door Conversion and Level 1 infill options provide a scalable, retrofit-ready pathway to ballistic hardening for doors, storefronts, and curtainwall systems—supporting layered, risk-based security strategies for schools, government facilities, retail, and commercial environments without disruptive structural modifications.



RIOT GLASS® UFS DOOR CONVERSION - UL 752 LEVEL 1 RATED

Riot Glass® has expanded its Universal Framing System (UFS) platform with a newly engineered Door Conversion System that has successfully passed UL 752 Level 1 ballistic testing. While optimized for glazed door retrofits, this system may also be deployed as a back-glazed ballistic framing solution within storefront and curtainwall applications, extending its utility beyond door assemblies alone.

The UFS Door Conversion enables the hardening of existing glazed openings without full system replacement—preserving architectural intent while materially increasing occupant protection.

The system integrates seamlessly with Riot Glass® AP-Series or RG-Series Level 1 infill panels, allowing project teams to align glazing performance with operational and threat-profile requirements:

- AP-Series (Level 1) – Multi-laminate construction delivering no spall and no “white-out,” maintaining critical visibility and minimizing secondary projectile risk post-impact.
- RG-Series (Level 1) – Hardened glass-based ballistic construction offering enhanced surface durability, with expected spall and white-out characteristics typical of glass-clad ballistic systems.
